GENERAL TERMS AND CONDITIONS OF SALE

**Acceptance/Governing Terms:** These General Terms and Conditions of Sale ("Terms and Conditions") apply to the sales of any goods by Weld On Adhesives, Inc. ("Seller"). Sales of any goods by Seller is expressly conditioned on the Buyer's consent to these Terms and Conditions. These Terms and Conditions shall be controlling over any additional, different, inconsistent or conflicting terms of any purchase order or other purchase documents of Buyer, and such additional, different, inconsistent or conflicting terms are expressly rejected. These Terms and Conditions may only be amended by a writing executed by duly authorized representatives of Seller and Buyer.

**Minimum Order:** \$500.00 Net

**Terms of Payment:** Net 30 days

**Freight Terms:** For orders of US \$2,000 net or more, shipments will be CPT (Seller's premises) (Incoterms 2010). Seller pays for transportation of the goods to one destination in the United States (excludes HI, AK, and US Protectorates); risk of loss passes to the Buyer when the goods have been delivered to the carrier. Seller reserves the right to choose the method of shipment and choice of routing. Not applicable to international orders.

For orders of less than US \$2,000, shipments will be EXW (Seller's premises) (Incoterms 2010). Buyer pays for the transportation of the goods; risk of loss passes to the Buyer when the goods have been made available to Buyer at Seller's premises.

Seller reserves the right to increase orders for less than standard packaging to minimum standard packaging quantities. Some items are exempt from prepaid freight and are determined as such by the Seller.

**Order Acceptance and Inspection:** Upon receipt of all shipments, Buyer shall inspect the shipment and confirm quantities and type of goods delivered. All shipments of goods shall be deemed to include the correct quantity and type of goods ordered unless the Buyer delivers written notice to Seller of any deficiencies within ten (10) days of receipt of shipment. Any damages to the goods in transit must be reported to Seller within three (3) days of receipt of goods by Buyer.

**Returned Goods:** Seller will not accept returned goods without prior authorization and issuance of a return authorization number, which number must be displayed on the outside of the shipping carton and packing slip. Authorized returns must be in full quantities, in original packaging, shipped prepaid, and are subject to a twenty-five percent (25%) restocking fee. Seller will not accept goods that have been discontinued or with less than one-half of the shelf life remaining.

**Limited Warranty for Goods with a Shelf Life:** Seller warrants to the original Buyer of the goods that all new Seller goods shall be free from defects in material and workmanship for the published shelf life of the good. If any Seller good fails to conform to this Limited Warranty under normal use and storage conditions, and if the original Buyer complies with the terms of this Limited Warranty, then Seller will, without charge to Buyer, replace the nonconforming good.

**Limited Warranty for Goods without a Shelf Life:** Seller warrants to the original Buyer of the goods that all new Seller goods shall be free from defects in material

and workmanship for one (1) year from the date a good is shipped to Buyer. If any Seller good fails to conform to this Limited Warranty under normal use and storage conditions, and if the original Buyer complies with the terms of this Limited Warranty, then Seller will, without charge to Buyer, replace the nonconforming good.

The Limited Warranties above shall not extend to, nor shall Seller be responsible for, damages or loss resulting from accident, misuse, negligent use, improper storage, or improper application.

**THESE LIMITED WARRANTIES ARE EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES. SELLER MAKES NO OTHER WARRANTIES, EXPRESS OR IMPLIED, EITHER IN FACT OR BY OPERATION OF LAW, STATUTORY OR OTHERWISE, AND EXPRESSLY DISCLAIMS ANY WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, ARISING FROM A COURSE OF DEALINGS, AND/OR FROM USAGE OF TRADE.**

**SELLER SHALL NOT BE LIABLE IN CONTRACT, IN TORT (INCLUDING NEGLIGENCE OR STRICT LIABILITY) OR OTHERWISE FOR ANY SPECIAL, INDIRECT, INCIDENTAL, PUNITIVE OR CONSEQUENTIAL DAMAGES.**
