



Weld-On Limited Warranty Certificate

- Weld-On Adhesives, Inc., warrants to the original purchaser ("Buyer") of new Weld-On products ("Products") that these shall be free from defects in material and workmanship for the Product's shelf life. If any Product is alleged to be defective or fails to substantially conform to Weld-On's published specifications under normal use and storage conditions, Buyer shall promptly notify Weld-On in writing of any alleged defect or non-conformance. (Buyer may be required to provide address of storage facilities, record of transport, and proof of storage and shipment within range of specification listed on product label).
- Buyer shall then return the alleged defective product with transportation charges prepaid, to the address shown below.

- If the warranty claim is valid, Weld-On will either replace the non-conforming unit(s) of Product at no product charge to the Buyer or offer a full refund of that portion of the purchase price allocable to the non-conforming Product, at Weld-On's discretion. (Buyer shall be required to provide certified proof of destruction of any nonconforming Product.) A warranty replacement product will not extend or renew the applicable warranty period.
- This limited warranty does not apply to, and Weld-On shall not be responsible for: (i) Products impacted by adverse conditions, extreme weather or temperatures, or other natural conditions; (ii) improper or unauthorized repair, installation or maintenance of the Products by a party other than Weld-On; (iii) use for purposes or under conditions other than those for which designed, or other abuse, negligence, misuse, unauthorized access, improper application or normal wear and tear; (iv) unauthorized attachments, modifications, disassembly or incorporation of Weld-On Products into other products; (v) damage during shipping; (vi) Products purchased from unauthorized distributors, resellers or internet sites; or, repackaged Products. (Buyer's care in selection, adequate testing at time of installation and proper installation, operation and maintenance of all products is required for adequate performance.)
- No representative of Weld-On has authority to waive, alter, vary or add to the scope of this warranty without prior written approval of an officer of Weld-On.
- THE FOREGOING WARRANTY IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. This warranty allocates the risks of product failure between Weld-On and Buyer. This allocation is recognized by both parties and is reflected in the price of the products. Buyer acknowledges that it has read this warranty, understands it, and agrees to and is bound by its terms.
